Technology education classes at Ames High School serve a diverse population. It is important to provide instruction for their individual needs. Addressing these needs involves using a variety of teaching methodologies. This action research study used a quasi-experimental design to evaluate the effectiveness of video tutorials on students' assignment completion in a beginning computer-aided drafting (CAD) course under the auspices of differentiated instruction. The research compared the number of assignments completed between treatment and control groups. Students enrolled in a beginning CAD course during the 2014/2015 school year were the control group, who relied on peers and the instructor for individual assistance. An analogous group enrolled in the same course during the 2015/2016 school year were the treatment group. In addition to peer and instructor assistance, they had access to teacherdeveloped video tutorials that could be viewed any time as often as needed. A Fisher's exact test determined if video tutorials improved student achievement, especially among those needing accommodations. The results showed statistically significant higher completion rates for students with access to video tutorials than those who did not. More specifically, the findings suggest video tutorials can be effective tools for differentiating instruction in a beginning CAD class.

Estimates indicate that as many as 1 in 4 Americans will experience a mental health problem or will misuse alcohol or drugs in their lifetimes. These disorders are among the most highly

In this quantitative study, reading results from the current state-mandated assessment, the State of Texas Assessment of Academic Readiness (STAAR), were analyzed to compare 30 transitional early exit program elementary schools with 30 dual language one-way program elementary schools in two Texas large urban school districts. Also analyzed were the Texas English Language Proficiency Assessment System (TELPAS) Reading scores between early exit program elementary schools with dual language oneway program elementary schools across the State of Texas. Data were requested and obtained from the Texas Education Agency Public Education Information Management System for the 2013-2014 and the 2014-2015 school years for Grade 3 students. Statistical analyses on the STAAR Reading test scores yielded mixed results. In the 2013-2014 school year, ELLs had better STAAR Reading test scores in the early exit transitional program than in the one-way bilingual education program; however, higher percentages of English Language Learners in the one-way dual language program met the performance standards. In the 2014-2015 school year, the STAAR Reading test scores and performance standard percentages were higher for ELLs in the one-way bilingual education program. Results on the TELPAS exam were consistent for both school years in that ELLs who were enrolled in an early exit transitional bilingual education program had higher TELPAS ratings and higher TELPAS scores than their counterparts who were enrolled in a one-way dual language bilingual education program. Based upon the results of the STAAR and the TELPAS statistical analyses, information is provided to school leaders regarding a comparison of ELL student performance in transitional early exit programs with dual language one-way bilingual education programs.

The High School is a rural school on the Standing Rock Indian Reservation in South Dakota. According to MAPS tests administered during the 2014-2015 school year, a majority of students in the 9th grade had a third-grade reading level. This state of affairs was evidenced when a student was asked to read aloud out of a textbook during class. The low reading level ability was reflected in the low scores a great number of students received in Freshman Science class. Most were experiencing learned helplessness and would not even participate in class which led to discipline problems. The purpose of an innovation would be to improve reading skills starting at the beginning of the students' life, and life in school in order for the student to have adequate reading capabilities in high school and beyond. That the teacher can affect the ability to read as early as Kindergarten is a possibility. It was found that a Kindergarten teacher's affective quality had an influence on working memory, which in turn effects skills in first grade. Most effective was the child's learning of independence through the way the teacher treated the student. In another study, it was found that development of the phonological loop aspect of working memory predicted better reading skills for Chinese students. The studies suggest that reading skills in children can be affected even earlier than in Elementary School. The students would benefit from a reading program to improve skills, as well as the teachers who could assign reading assignments and have students read in class, the school would benefit because scores would increase.
